

#### **WARRANTY COVERAGE:**

HHT warrants that the Products and their Component Parts will be free from defects in materials and workmanship for the applicable period of Warranty coverage set forth in the table below ("Warranty Period"). If a Product or Component Parts are found to be defective in materials or workmanship during the applicable Warranty Period, HHT will, at our discretion, repair the applicable Component Part(s), replace the applicable Component Part(s), or refund the purchase price of the applicable Product(s). The maximum amount recoverable under this Warranty is limited to the purchase price of the Product. This Warranty is transferable from the original purchaser to subsequent owners, but the Warranty Period will not be extended in duration or expanded in coverage for any such transfer. This Warranty is subject to conditions, exclusions, and limitations as described below.

#### **WARRANTY PERIOD:**

Warranty coverage begins at the date of installation. In the case of new home constructions, Warranty coverage begins six months after invoice of the final sale of the Product(s) by an independent, authorized HHT dealer or distributor. # **B. Limited Lifetime Warranty (Continued)**

#### **WARRANTY CONDITIONS:**

- Because HHT cannot control the quality of any Products sold by unauthorized sellers, this Warranty only covers Products that are
  purchased through an HHT authorized dealer or distributor unless otherwise prohibited by law; a list of HHT authorized dealers
  is available on the HHT branded websites.
- This Warranty is only valid while the applicable Product remains at the site of original installation.
- This Warranty is only valid in the country in which the HHT authorized dealer or distributor that sold the applicable Product is authorized to sell applicable Product.
- Contact your installing distributor or dealer for Warranty service. If the installing dealer or distributor is unable to provide
  necessary parts, contact the nearest HHT authorized dealer or supplier. Additional service fees may apply if you are seeking
  Warranty service from a dealer other than the dealer from whom you originally purchased the applicable Product.
- No HHT consumer should bear cost of warranty service or costs incurred while servicing warranty claims (i.e., travel, gas, or mileage) when the service is performed within the terms of this Warranty. Check with your dealer or distributor in advance for any costs to you when arranging a warranty call. Travel and shipping charges for parts are not covered by this Warranty.

#### **WARRANTY EXCLUSIONS:**

This Warranty does not cover the following:

- Changes in surface finishes as a result of normal use. As a heating appliance, some changes in color of interior and exterior surface
  finishes may occur. This is not a flaw and is not covered under the Warranty.
- Damage to printed, plated, or enameled surfaces caused by fingerprints, accidents, misuse, scratches, melted items or other external sources and residues left on the plated surfaces from the use of abrasive cleaners or polishes.
- Repair or replacement of parts that are subject to normal wear and tear during the Warranty Period are not covered. These parts include: paint, wood and pellet gaskets, firebricks, wood grates, flame guides, batteries and the discoloration of glass.
- Minor expansion, contraction, or movement of certain parts causing noise. These conditions are normal and complaints related to this noise are not covered by this Warranty.
- Damages resulting from: (1) failure to install, operate, or maintain the applicable Product in accordance with the installation instructions, operating instructions, and listing agent identification label furnished with the applicable Product; (2) failure to install the applicable Product in accordance with local building codes; (3) shipping or improper handling; (4) improper operation, abuse, misuse, continued operation with damaged, corroded or failed components, accident, or improperly/incorrectly performed repairs; (5) environmental conditions, inadequate ventilation, negative pressure, or drafting caused by tightly sealed constructions, insufficient make-up air supply, or handling devices such as exhaust fans or forced air furnaces or other such causes; (6) use of fuels other than those specified in the operation instructions; (7) installation or use of components not supplied with the applicable Product or any other components not expressly authorized and approved by HHT; (8) modification of the appliance not expressly authorized and approved by HHT in writing; and/or (9) interruptions or fluctuations of electrical power supply to the applicable Product.
- Non-HHT venting components, hearth connections or other accessories used in conjunction with the applicable Product.
- Any part of a pre-existing fireplace system in which an insert or a decorative gas applicable Product is installed.
- HHT's obligation under this Warranty does not extend to the Product's capability to heat the desired space. Information is provided
  to assist the consumer and the dealer in selecting the proper Product for the application. Consideration must be given to the
  Product location and configuration, environmental conditions, insulation and air tightness of the structure.

# This warranty is void if:

- The applicable Product has been over-fired, operated in atmospheres contaminated by chlorine, fluorine, or other damaging chemicals. Over-firing can be identified by, but not limited to, warped plates or tubes, deformation/warping of interior cast iron structure or components, rust colored cast iron, bubbling, cracking and discoloration of steel or enamel finishes.
- The applicable Product is subjected to prolonged periods of dampness or condensation.
- There is any damage to the applicable Product due to water or weather damage which is the result of, but not limited to, improper chimney or venting installation.

#### LIMITATIONS OF REMEDIES AND LIABILITY:

• EXCEPT TO THE EXTENT PROVIDED BY LAW, HHT MAKES NO EXPRESS WARRANTIES OTHER THAN THE WARRANTY SPECIFIED HEREIN. The owner's exclusive remedy and HHT's sole obligation under this Warranty or in contract, tort or otherwise, shall be limited to, at HHT's sole option, replacement of the Component Part(s), repair of the Component Part(s), or refund of the original purchase price of the applicable Product(s). In no event will HHT be liable for any incidental or consequential damages caused by defects in the applicable Product. This Warranty gives you specific legal rights and you may also have other rights which vary from State to State. # D. High Altitude Installations

When installing above 2000 feet elevation:

- In the USA: Reduce input rate 4% for each 1000 feet above 2000 feet.
- In CANADA: Input ratings are certified without a reduction of input rate for elevations up to 4500 feet (1370 m) above sea level. Please consult provincial and/ or local authorities having jurisdiction for installations atelevations above 4500 feet (1370 m). Check with your local gas utility to determine proper orifice size.

#### E. Fuel

# H. Requirements for the Commonwealth of Massachusetts

For all side wall horizontally vented gas fueled equipment installed in every dwelling, building or structure used in whole or in part for residential purposes, including those owned or operated by the Commonwealth and where the side wall exhaust vent termination is less than seven (7) feet above finished grade in the area of the venting, including but not limited to decks and porches, the following requirements shall be satisfied:

#### Installation of Carbon Monoxide Detectors

At the time of installation of the side wall horizontal vented gas fueled equipment, the installing plumber or gas fitter shall observe that a hard wired carbon monoxide detector with an alarm and battery back-up is installed on the floor level where the gas equipment is to be installed. In addition, the installing plumber or gas fitter shall observe that a battery operated or hard wired carbon monoxide detector with an alarm is installed on each additional level of the dwelling, building or structure served by the side wall horizontal vented gas fueled equipment. It shall be the responsibility of the property owner to secure the services of qualified licensed professionals for the installation of hard wired carbon monoxide detectors.

In the event that the side wall horizontally vented gas fueled equipment is installed in a crawl space or an attic, the hard wired carbon monoxide detector with alarm and battery back-up may be installed on the next adjacent floor level.

In the event that the requirements of this subdivision can not be met at the time of completion of installation, the owner shall have a period of thirty (30) days to comply with the above requirements; provided, however, that during said thirty (30) day period, a battery operated carbon monoxide detector with an alarm shall be installed.

# **Approved Carbon Monoxide Detectors**

Each carbon monoxide detector as required in accordance with the above provisions shall comply with NFPA 720 and be ANSI/UL 2034 listed and IAS certified.

### Signage

A metal or plastic identification plate shall be permanently mounted to the exterior of the building at a minimum height of eight (8) feet above grade directly in line with the exhaust vent terminal for the horizontally vented gas fueled heating appliance or equipment. The sign shall read, in print size no less than one-half (1/2) in. in size, "GAS VENT DIRECTLY BELOW. KEEP CLEAR OF ALL OBSTRUCTIONS".

#### Inspection

The state or local gas inspector of the side wall horizontally vented gas fueled equipment shall not approve the installation unless, upon inspection, the inspector observes carbon monoxide detectors and signage installed in accordance with the provisions of 248 CMR 5.08(2)(a)1 through 4.

#### **Exemptions**

The following equipment is exempt from 248 CMR 5.08(2) (a)1 through 4:

- The equipment listed in Chapter 10 entitled "Equipment Not Required To Be Vented" in the most current edition of NFPA 54 as adopted by the Board; and
- Product Approved side wall horizontally vented gas fueled equipment installed in a room or structure separate from the dwelling, building or structure used in whole or in part for residential purposes.

#### MANUFACTURER REQUIREMENTS

### **Gas Equipment Venting System Provided**

When the manufacturer of Product Approved side wall horizontally vented gas equipment provides a venting system design or venting system components with the equipment, the instructions provided by the manufacturer for installation of the equipment and the venting system shall include:

- Detailed instructions for the installation of the venting system design or the venting system components; and
- A complete parts list for the venting system design or venting system.

# Gas Equipment Venting System NOT Provided

When the manufacturer of a Product Approved side wall horizontally vented gas fueled equipment does not provide the parts for venting the flue gases, but identifies "special venting systems", the following requirements shall be satisfied by the manufacturer:

- The referenced "special venting system" instructions shall be included with the appliance or equipment installation instructions; and
- The "special venting systems" shall be Product Approved by the Board, and the instructions for that system shall include a parts list and detailed installation instructions.

A copy of all installation instructions for all Product Approved side wall horizontally vented gas fueled equipment, all venting instructions, all parts lists for venting instructions, and/or all venting design instructions shall remain with the appliance or equipment at the completion of the installation.

# **Clear Space**

Avoid placing candles, electronics and other heat-sensitive objects on mantel or hearth. Heat may damage these objects.





Figure 3.1 Clear Space Requirements

# Over Firing

The appliance is considered to be over firing if the flames are contacting the top of the firebox. Call a qualified service technician to service the appliance.

# **Getting Started**

# A. Design and Installation Considerations

Installation MUST comply with local, regional, state and national codes and regulations. Consult insurance carrier, local building inspector, fire officials or authorities having jurisdiction over restrictions, installation inspection and permits.

Before installing, determine the following:

- Where burner assembly and log set are to be installed.
- Gas supply piping.
- Whether optional accessories, devices such as a wall switch or remote control are desired.
- Approved wood burning or masonry fireplace.

Installation and service of this appliance should be performed by qualified personnel. Hearth & Home Technologies recommends HHT Factory Trained or NFI certified professionals.

# B. Tools and Supplies Needed

- Drill and bits
- External regulator (for propane/LP only & 1/2 psi Natural gas system)
- Piping which complies with local codes
- Pipe sealant approved for use with propane/LP (Resistant to sulfur compounds)

# **A** CAUTION

Gloves are recommended when handling refractory and logs to prevent skin irritation from loose fibers. Logs are fragile; handle with care.

# C. Inspect Appliance and Components

- Carefully remove the applaince and components from the packaging.
- Attached to the appliance are tags identifying the manufacturer, serial number, model number. Including log set size, BTU/hr ratings and gas type.
- Review the attached tags before proceeding. Ensure that all minimum fireplace dimension requirements are achieved using Figure 4.1.
- Ensure the gas type provided in the fireplace coincide with the gas type marked on the tag.
- Logs are packaged and sold separately.
- Report to your dealer any parts damaged in shipment.
- Read all of the instructions before starting the installation. Follow these instructions carefully during the installation process to ensure maximum safety and benefit.

NARNING! Risk of Fire or Explosion! Damaged parts could impair safe operation. DO NOT install damaged, incomplete or substitute components. Keep appliance dry.



### F. Installation Information

# WARNING

This appliance is for installation only in a solid-fuel burning masonry or UL127 factory-built fireplace. It has been design certified for these installations.

**Note:** Use manufacturer's installation and clearance requirements as defined in their manual.

# BEFORE INSTALLING THE APPLIANCE:

- Turn off gas supply to masonry fireplace or manufactured wood burning firebox.
- Have the fireplace floor and chimney professionally cleaned to remove ash, soot, creosote or other obstructions. Have this cleaning performed annually after installation.
- Seal any fresh air vents or ash clean-out doors located on floor or wall of fireplace. If not, drafting may cause pilot outage or sooting. Use a heat-resistant sealant.

# WARNING

# Do not install the applaince:

- Where curtains, furniture, clothing, or other flammable objects are less than 36" from the front of the heater.
- In high traffic areas.
- · In windy or drafty areas.

# **Damper Stop Installation**

A damper stop is provided with this appliance. The damper stop MUST be installed to prevent full closure of the fireplace damper blade and provide a minimum flue opening. See Table 4.1.




Figure 4.2 Factory Built Fireplace Example

Factory Built Fireplace: Position damper stop on the top half of the damper blade, slide stop towards the center of the damper blade to create an interferance with the bead on the flue collar and tighten bolt. Either side of the damper blade is acceptable. See Figure 4.2.

**Note:** Should the stop not fit, or provide the required permanent opening from the table have the damper blade cut to provide minimum permanent opening or a permanent stop installed.

# WARNING

Improper installation or use of the appliance can cause serious injury or death from fire, burns, explosion or carbon monoxide poisoning.




Figure 4.3 Masonary Fireplace Example



The fireplace and gas logs function as a system. If the fireplace is spilling into the room (check with a match or smoke stick), reposition the damper clamp until a positive draft is obtained, by opening the damper. If negative pressure in the home prevents having a positive draft contact your dealer.

# For Massachusetts Residents Only

Installation of this vented gas log set in the Commonwealth of Massachusetts requires the damper be permanently removed or welded in the fully open position. In addition, a naturally vented gas log may not be installed in a bedroom or bathroom in the Commonwealth of Massachusetts.

# G. Adequate Combustion Ventilation Air

This appliance shall not be installed in a confined space or unusually tight construction unless provisions are provided for adequate combustion and ventilation air.

The National Fuel Gas Code, (ANSI Z223.1/NFPA54), defines a confined space as a space whose volume is less than 50 cubic feet per 1,000 BTU per hour (4.8m³ per kw) of the aggregate input rating of all appliances installed in that space. Rooms communicating directly with the space in which the appliances are installed, through openings not furnished with doors, are considered a part of a confined space.

# WARNING

If the area in which the appliance may be operated does not meet the required volume for indoor combustion air, combustion and ventilation air shall be provided by one of the methods described in the National Fuel Gas Code, ANSI Z223.1/NFPA 54, the International Fuel Gas Code or applicable local codes.

# H. Negative Pressure

Negative pressure results from the imbalance of air available for the fireplace to operate properly. Possible causes for this imbalance include:

- Exhaust fans (kitchen, bath, etc.)
- Range hoods
- Combustion air requirements for furnaces, water heaters and other combustion appliances
- Clothes dryers
- Location of return-air vents to furnace or air condition-
- Imbalances of the HVAC air handling system
- Upper level air leaks: recessed lighting, attic hatch opening, duct leaks.

# WARNING

Use new black iron or steel pipe. Internally tinned copper or copper tubing can be used per National Fuel Code, providing gas meets hydrogen sulfide limits, and where permitted by local codes. Gas piping system must be sized to provide minimum inlet pressure (Listed on Data Plate) at the maximum flow rate (BTU/hr). Undue pressure loss will occur if the pipe is too small.

A manual shutoff valve must be installed upstream of the appliance. Union tee and plugged 1/8" NPT pressure tapping point should be installed upstream of the appliance.

# A. Fuel Type

The gas supply must be the same as stated on the appliance rating plate. If the gas supply is different, DO NOT INSTALL THE APPLIANCE. Contact your dealer for the correct model.

CHECK GAS TYPE: The gas supply must be the same as stated on the appliance rating plate. If the gas supply is different, DO NOT INSTALL THE APPLIANCE. Contact your dealer for the correct model.

### **B.** Gas Pressure

- Optimum appliance performance requires proper input pressures.
- Gas line sizing requirements will be determined in ANSI Z223.1 National Fuel Gas Code in the USA.
- Pressure requirements are:

Fire Risk! Explosion Hazard!

High pressure will damage valve!

- Disconnect gas supply piping BEFORE pressure testing gas line at test pressures above 1/2 psig.
- Close the manual shutoff valve BEFORE pressure testing gas line at test pressures equal to or less than 1/2 psig.

**Note:** Have the gas supply line installed in accordance with local codes, if any. If not, follow ANSI Z223.1. Installation should be done by a qualified installer approved and/or licensed as required by the locality (In the Commonwealth of Massachusetts installation must be performed by a licensed plumber or gas fitter).

**Note:** A listed (and Commonwealth of Massachusetts approved) 1/2 in. (13 mm) T-handle manual shut-off valve must be installed upstream of the appliance.

**IMPORTANT:** Install manual shutoff valve in an accessible location. The manual shutoff valve is for turning on or shutting off the gas to the appliance.

**WARNING!** Risk of Fire or Explosion! High pressure will damage valve. Low pressure could cause explosion.


- Verify inlet pressures. Verify minimum pressures when other household gas appliances are operating.
- Install regulator upstream of valve if line pressure is greater than 1/2 psig.

#### C. Gas Connection

A 3/8 in. flared fitting has been installed on the gas valve inlet at the factory. Ensure fittings are of the appropriate size and type on the gas line connection. If the tubing has to be cut to length be sure to use the proper cutting and flaring tool. Also, be careful not to crimp the tubing while bending. If the tubing becomes crimped, do not use for installation.

**IMPORTANT:** When tightening up the joint to the valve, hold the valve securely to prevent movement.

Test all gas joints from the gas meter to the appliance valve for leaks using a gas analyzer or soap and water solution after completing connection. DO NOT USE AN OPEN FLAME. Check the gas pressure with the appliance burning.



# D. Verify Gas Pressure

The valve regulator controls the burner pressure. Gas pressure must be verified at both the inlet and outlet pressure test ports.




Figure 5.2 Pressure Test Ports

- 1. Turn captured screw counterclockwise two or three turns. See Figure 5.2.
- 2. Place tubing from pressure gauge over test port.
- 3. After taking pressure readings, be sure and turn captured screw clockwise firmly to re-seal. Do not over torque.
- 4. Check for gas leaks.

# **Electrical Information**

# A. Wiring Requirements

WARNING! Risk of Shock or Explosion! DO NOT wire 110-120 VAC to the valve. Incorrect wiring will damage controls.

- The intermittent pilot ignition system (IPI) on the Stadium series gas log set comes standard with an integrated battery pack, that holds (2) D size batteries.
- The appliance does NOT require 110 VAC for operation. If the vented fireplace/firebox the appliance is installed in is electrically wired, it must be wired and grounded in accordance with local codes or, in the absence of local codes, with National Electric Code ANSI/NFPA 70-latest edition.




Figure 6.1 IPI Wiring Diagram

- An ON/OFF Switch and Remote Control are supplied with the appliance. The Remote Control can be incorporated into this system by connecting to the remote switch wires as shown. See Figure 6.1

**NOTE**: The use of a thermostat is prohibited in vented log installations.

WARNING! Risk of Shock! Label all wires prior to disconnection when servicing controls. Wiring errors can cause improper and dangerous operation. Verify proper operation after servicing. Replace damaged wire with type 105° C rated wire. Wire must have high temperature insulation.

# **WARNING**

You must secure the gas log appliance to the fireplace floor. If not, the entire unit may move when you adjust the controls. Movement of unit may cause shifting of the gas logs which leads to sooting and improper burning. Grate movement could cause a gas leak.

# A. Positioning the Appliance

The appliance is assembled with the gas controls installed at the factory, and is designed to connect the 3/8" supply line before making final placement inside the fireplace.

- 1. Place the appliance towards the rear and center of the fireplace and connect the gas line.
- 2. Tighten incoming gas connection. Follow instructions in Section 5.C Gas Connection to check for gas leaks.
- Center the gas log appliance in the fireplace. Make certain the entire appliance and grate sit inside the front edge of the fireplace. Ensure the appliance is positioned correctly, side to side and front to back.




Figure 7.1 Batteries and Log Cover

- 4. This appliance includes a battery box which holds 2 "D" size batteries. The battery box should be placed in the right front corner of your fireplace and covered with the log cover as shown in Figure 7.1.

Note: Proper installation of the appliance is essential to prevent movement of the gas logs and controls during operation.

### B. On/Off Switch and Remote Control

This vented log set comes supplied with an On/Off Switch and a battery powered remote control kit.




Figure 7.2 On/Off Switch and Remote Connection

- The On/Off switch is located on the front right side of the burner assembly as shown in Figure 7.2.
- The supplied remote control can be incorporated with this system by connecting the remote wires to the connection wires shown in Figure 7.2.

Note: Position the remote control receiver in a convenient location, which allows for safe operation of the appliance and replacement of batteries, as necessary.

# C. Natural Gas Set-up

#### **Burner Media Placement:**

- 1. Pour sand into each burner pan to the point where the burner pipe is covered.




Figure 7.3 Sand Placement

- 2. Level the sand from side to side to ensure an even flame pattern. At this point the pans should be half full. See Figure 7.3.

Note: Be sure NOT to cover Pilot Assembly.

3. Pour vermiculite over the sand in each pan until they are full. See Figure 7.4.




Figure 7.5 Rock Wool Placement

4. Lightly place dime-size pieces of rock wool evenly all over the vermiculite to achieve a glowing ember effect. See Figure 7.5.

Note: For best results, do not pack down the rock wool. The placement of rock wool can have an effect on flame pattern and may need to be adjusted to achieve a desired appearance.

5. Inspect the Pilot Assembly to ensure it is clear of any sand, vermiculite or rock wool.

 Remove the Platinum Bright Embers™ from the package. For optimum performance peel each piece apart in layers and lightly place on top of the rock wool where the flame is blue. This will achieve the desired realism.

Note: Gas burns at the point of the least resistance. In the case of an uneven flame pattern it may be necessary to adjust the media material in the pans, using an object such as a screwdriver, to achieve the desired effect.

#### DO NOT:

- Pile the glowing embers too heavily on the pan.
- Cover the pilot with glowing embers

#### **Decorative Lava Rock Placement:**

- 1. Place desired amount of decorative lava rock on the floor of the fireplace.
- 2. Ensure all controls and switches are unobstructed after decorative lava rock has been placed.

#### DO NOT:

- Place decorative lava rock on the burner, pilot or logs.
- Allow decorative lava rock to come in contact with the flames. Lava rocks may contain moisture which, when heated, may cause it to popout during operation.

# **WARNING**

The positioning of the grate, logs and media is critical to the safe and clean operation of this appliance. Sooting and other problems may result if the logs are not properly positioned in the appliance. Never add additional logs or embellishments such as pine cones. Only use the logs and media supplied with the unit.

Failure to position the parts in accordance with installation instructions or failure to use only parts specifically approved for this appliance may result in property damage or personal injury.

# D. Propane (LP) Gas Set-up

# **WARNING**

An explosion could occur if a connection is made directly to an unregulated propane (LP) tank.

#### **Burner Media Placement:**

- 1. Pour vermiculite into each burner pan to the point where each pan is completely full.




Figure 7.6 Vermiculite Placement

- 2. Level the vermiculite from side to side to ensure an!even flame pattern. See Figure 7.6.

Note: Be sure NOT to cover Pilot Assembly.

Pour vermiculite into each burner pan (LP) to the point where each pan is completely full. Failure to do so may cause the lighting to be delayed and this can be dangerous.




Figure 7.7 Rock Wool Placement

 Lightly place dime-size pieces of rock wool evenly all over the vermiculite to achieve a glowing ember effect. See Figure 7.7.

Note: For best results, do not pack down the rock wool. The placement of rock wool can have an effect on flame pattern and may need to be adjusted to achieve a desired appearance.

4. Inspect the Pilot Assembly to ensure it is clear of any vermiculite or rock wool.

 Remove the Platinum Bright Embers™ from the package. For optimum performance peel each piece apart in layers and lightly place on top of the rock wool where the flame is blue. This will achieve the desired realism.

Note: Gas burns at the point of the least resistance. In the case of an uneven flame pattern it may be necessary to adjust the media material in the pans, using an object such as a screwdriver, to achieve the desired effect.

### DO NOT:

- Pile the glowing embers too heavily on the pan.
- Cover the pilot with glowing embers

#### **Decorative Lava Rock Placement:**

- 1. Place desired amount of decorative lava rock on the floor of the fireplace.
- 2. Ensure all controls and switches are unobstructed after decorative lava rock has been placed.

#### DO NOT:

- Place decorative lava rock on the burner, pilot or logs.
- Allow decorative lava rock to come in contact with the flames. Lava rocks may contain moisture which, when heated, may cause it to popout during operation.
- Cover the air mixer located on the lower left side of the burner

# E. Log Placement

The Stadium series vented log set has multiple log options to choose from. These logs are sold seperately.

For log placement instructions refer to the installation instructions supplied with the log set.

**NOTE:** The appliance is designed to be operated with one of the optional log sets installed. Do NOT operate this appliance without a log set installed.

# F. Before Lighting Appliance

Before operating this appliance for the first time, have a qualified service technician:

- Verify all shipping material have been removed from inside and/or underneath the gas log set.
- Review proper placement of logs.
- · Ensure there are no gas leaks.

**Caution:** This appliance must NOT be operated with glass doors in the closed position.

# G. Flame Appearance

Flames from the pilot and burner should be visually checked as soon as the appliance is installed. In addition, periodically check the flames visually during operation.

#### **Pilot Flame:**

The IPI pilot flame must always be present when the appliance is in operation. Pilot flame should engulf the flame sensor rod. See Figure 7.8.

If the pilot flame does not touch the flame sensor, then the main burner cannot function reliably.

# Main Burner Flame:

Operate the appliance at full rate for 45 minutes, the following flame appearances should be observed.

Burner will have a random pattern of yellow flames, with glowing embers covering the main burner.

**Note:** This appliance is a vented gas log set, therefore some flame impingement and soot is normal.

Avoid any drafts that alter burner flame patterns. Do not allow fans to blow directly on the appliance. Do not place a blower inside the burn area of the fireplace. Ceiling fans may create drafts that alter flame patterns. Sooting and improper burning will result.

#### H. Initial Use

Initial Break-in Procedure:

- The burner should run three to four hours continuously on high.
- Turn the burner off and allow it to completely cool.


This cures the materials used to manufacture the burner. NOTICE! Open windows for air circulation during appliance break-in.

- Some people may be sensitive to smoke and odors.
- Smoke detectors may activate.


# A. Intermittent Pilot (IPI)

# LIGHTING INSTRUCTIONS

- 1. STOP! Read the safety instruction label.
- 2. Turn wall switch to the "OFF" position.



- Wait five minutes to clear out any gas. If you smell gas, STOP! Follow "B" on the safety information label. If you don't smell gas, go to next step.
- 4. Locate pilot assembly inside unit.




- 5. To light pilot and main burner, turn wall switch to "ON". Don not light by hand.
- If appliance will not operate, follow the instructions "TO TURN OFF GAS TO APPLI-ANCE" and call your service technician or gas supplier.

# B. Maintenance Tasks: Qualified Service Technician

The following tasks must be performed by a qualified service technician.

# Pilot Inspection & Cleaning

Frequency: Annually

By: Qualified Service Technician

Tools needed: Small soft brush, pipe cleaner

- Inspect and remove dust, spider webs and lint
- Gently run pipe cleaner through air intake port
- Inspect IPI flame sensing rod for soot, corrosion an deterioration. Polish with 320 grit Emery cloth and/or 3M™ Scotch-Brite Abrasive Hand Pad.

# Log Inspection

Frequency: Annually

**By:** Qualified Service Technician **Tools needed:** Small soft brush

Inspect for broken, cracked or misplaced logsGently remove any dust and/or soot buildup

# **Firebox Inspection**

Frequency: Annually

By: Qualified Service Technician

**Tools needed:** Protective gloves, sandpaper, steel wool, cloths, mineral spirits, primer and touch-up paint.

- Inspect for paint condition, warped surfaces, corrosion or perforation. Sand and repaint as necessary.
- Replace fireplace if firebox has been perforated.

# **Burner Ignition and Operation**

Frequency: Annually

By: Qualified Service Technician

**Tools needed:** Protective gloves, vacuum cleaner, whisk broom, flashlight, voltmeter, indexed drill bit set, and a manometer.

- Verify burner is properly secured and aligned with pilot or igniter.
- Clean off burner top, inspect for plugged ports, corrosion or deterioration. Replace burner if necessary
- Inspect for lifting or other flame problems.
- Inspect orifice for soot, dirt and corrosion. Verify orifice size is correct. See Service Parts List for proper orifice sizing.
- Verify manifold and inlet pressures. Adjust regulator as required.
- Inspect pilot flame pattern and strength. Clean or replace orifice spud as necessary.

# C. Cleaning and Servicing

Annual inspection and cleaning by your dealer or qualified service technician is recommended to prevent malfunction and/or sooting.

**Caution!** Before cleaning make sure the appliance is cool and the power to the unit is turned off.

**Note:** During normal operation it is common that some sooting may occur on the logs as well as internal panels. This can be more prevalent with propane (LP). Clean soot from the appliance as frequently as necessary to eliminate a buildup of soot or permanent discoloration.

### Periodic Cleaning:

- Remove logs carefully, by holding gently at each end.
   Gloves are recommended to prevent skin irritation. If skin irritation occurs, wash gently with soap and water.
   Refer to installation manual for correct log placement.
- Do NOT use cleaning fluid to clean logs or any part of the appliance.
- Brush logs with soft bristle brush or vacuum with brush attachment.
- Vacuum loose particles and dust from the burner, controls and grate weldment.
- · Replace battery in remote control device.

# Annual Cleaning/Inspection:

- Inspect and clean burner air intake shutter. Remove lint or particles with vacuum, brush, or pipe cleaners.
   Failure to keep air intake shutter clean may result in sooting and/or poor combustion.
- Inspect and clean all burner ports.
- Inspect pilot for proper operation.
- Verify flame pattern and log placement for proper operation.
- · Verify smooth and responsive ignition of main burner

If not using the appliance for an extended period (e.g.: summer months, vacation/trips, etc.):

 Remove batteries from remote and battery pack to avoid corrosion.

# 10 Troubleshooting

# A. Frequently Asked Questions

ISSUE	SOLUTION
Odor from appliance	When first operated, this appliance may release an odor for the first several hours. This is caused by the burning off of any oils remaining from manufacturing. Odor may also be released from finishing materials and adhesives used around the appliance.
Metallic noise	Noise is cause by metal expanding and contracting as it heats up and cools down, similar to the sound produced by a furnace or heating duct. This noise does not affect the operation or longevity of the appliance.
Wall above appliance feels hot to the touch	The area around, specifically above the firebox opening will become hot to the touch during operation. This is normal, no action is necessary.

# **B.** Troubleshooting

With proper installation, operation and maintenance your gas appliance will provide years of trouble-free service. If you do experience a problem, this troubleshooting guide will assist a qualified service technician in the diagnosis of a problem and the corrective action to be taken. This troubleshooting guide should only be used by a qualified service technician. Contact a dealer to arrange a service call by a qualified service technician.

	Ignitor gap is too large	Verify gap of igniter to right side of pilot hood. The gap should be approximately .125 in. or 1/8 in. (3 mm).
	Bad/Dead Batteries	Replace (2) D size batteries, located on the right side of appliance.
Pilot won't light. There is no noise or spark.	A shorted or loose connection in wiring configuration or wire harness.	Remove and reinstall the wiring harness that plugs into module. Verify there is a tight fit. Verify pilot assembly wiring to module. Remove and verify continuity of each wire in wiring harness. Replace any damaged components.
	Module not grounded	Verify black ground wire from module wire harness is grounded to metal chassis of appliance.
